A 1975 mid-year review confirms economists' predictions of a year with continuing inflation and recession around the country. Keeping the predictions in mind, RCCU anticipated a stabilization of economic growth.

Despite the economic trends, the statement of financial condition reflects an increase in assets of more than one million dollars. RCCU continued an annual dividend rate of 6½% resulting in the distribution of \$838,482.83 to members.
